I am exercising my right under the Freedom of Information Act today for this reason: The BIA FOIA Office has mis-handled, delayed and ignored previous FOIA requests I have submitted. See 5 U.S.C. 522 (a) (6) (A) (i) Reference a few examples: June 23, 2010 FOIA Control No. BIA-2010-01061 - BIA Ignored this request then finally responded 1 year and 3 months later. March 9, 2011 FOIA Control No. BIA2011-00574 - BIA Ignored this one also, then responded 6 months later. July 25, 2011 FOIA Appeal No. 2011-117 - BIA Responded 3 Months later. I am concerned that the lack of response to my requests could be due to a possible cover up of the on-going fraud, waste and abuse of power that continues to perpetuate under the Management of Mr. Michael Black, by his protégé Ms. Jeanette Hanna. The same kind of harassment, intimidation, harm and disregard for established federal processes that was found by the 2009 BIA Investigation to have been validated and confirmed as having been committed by Jeanette Hanna in Muskogee, Oklahoma are now being committed by Jeanette Hanna in Washington, DC. For these reasons, I am compelled to submit a formal request under the FOIA, for the following items: 1. All Email records and all other communications between BIA Management and BIA FOIA personnel between January 1 2013 to present that pertain to the process of filling Crystal Bond's FOIA Requests, specifically all email and other communications initiated, received or sent by Jeanette Hanna, Tommy Thompson, Michael Black, Larry EchoHawk, Paul Tsoasie and by all FOIA Officers and staff tasked with responding to my FOIA requests. 2. All Email records generated, initiated by, received by and mailed by Jeanette Hanna that are in any way related to any of Crystal Bond's FOIA Requests submitted to the BIA FOIA Office between January 1, 2010 and present, including all communications between Jeanette Hanna and all BIA FOIA personnel. 3. All Emails and other communications regarding the processing of all of Crystal Bond's FOIA Requests regarding Jeanette Hanna from January 1, 2010 to present. I am interested in the process that has been used as per BIA Management, to handle the FOIA Requests I have submitted which pertain to Jeanette Hanna.
