

Federal Wildfire Resources

This document describes a variety of pre-disaster Federal grant and cost-share programs across USDA and FEMA that can support community-led efforts to prepare for wildfire.

FEMA Resources for Communities

US Fire Administration State Fire Training Grants

The US Fire Administration (USFA) provides a \$20,000 grant each year to each state fire training agencies to bolster the delivery of National Fire Academy classes to career and volunteer fire and emergency services agencies from state, local, Tribal, and territorial organizations.

Assistance to Firefighters Grant Programs

The Assistance to Firefighters Grant Programs fund critically needed resources to equip and train emergency personnel, enhance efficiencies, and support community resilience.

FEMA Hazard Mitigation Grant Program

Funds are provided to state, local, Tribal, and territorial governments so that they can rebuild in a way that reduces or mitigates future disaster losses in communities nationwide. Each project submitted to FEMA’s Hazard Mitigation Assistance (HMA) grant programs for funding are required to meet basic eligibility criteria by being cost effective, technically feasible and effective, and in compliance with all applicable Environmental Historic Preservation laws. FEMA-approved Hazard Mitigation Plans are also required to apply for funding.

Working Document

Wildfire projects require significant environmental and cultural reviews, including coordination with resource agencies, assessment of environmental and cultural impacts, and more scrutiny on feasibility and cost-effectiveness. This process is intended to ensure that considerations are made to avoid or minimize impacts a project may have on sensitive and culturally-important resources and can require FEMA to solicit public comment.

FEMA's Building Resilient Infrastructure and Communities (BRIC) program provides support to states, local communities, Tribes, the District of Columbia, and territories as they undertake hazard mitigation projects, reducing the risks they face from disasters and natural hazards.	<p>Eligible states, Federally-recognized Tribes, the District of Columbia, and territories can apply and submit applications on behalf of sub-applicants for funding via the FEMA GO grant management system.</p> <p>Learn more about the FEMA GO system, including user guides and templates. The Community Wildfire Defense Grant Program was authorized and funded in the Bipartisan Infrastructure Law and provides grants to communities at risk from wildfire to develop or revise their community wildfire protection plans and carry out projects described within those plans. Funding is available for a 5-year period, Fiscal Year 2022 through Fiscal Year 2026.

Wildland Urban Interface Grant Program

The Wildland Urban Interface (WUI) competitive grant program is managed as part of the State Fire Capacity program. State Fire Capacity funding is used for competitive grants to local communities and other organizations to assist with mitigating risk from wildfire within the WUI. Grants are available and awarded through a competitive process with emphases on hazard fuel reduction in the WUI, information and education, assessment and planning, and monitoring through community and landowner action.

Volunteer Fire Capacity Grant Program

The Volunteer Fire Capacity program is a competitive grant program managed by state forestry agencies that assists rural volunteer fire departments with improving their capacity and capability to suppress wildfires. Grant funding may be used for purposes such as training, equipment, and apparatus.

Landscape Scale Restoration Program

The Landscape Scale Restoration Program is a Forest Service State and Private Forestry competitive grant program that promotes collaborative, science-based restoration of priority forest landscapes and furthers priorities identified in [State Forest Action Plans](#) or equivalent restoration strategies. Landscape Scale Restoration projects cross multiple jurisdictions, including Tribal, state and local government, and private forest land, to address large-scale issues such as wildfire risk reduction, watershed protection and restoration, and the spread of invasive species, insect infestation and disease.

Regional Conservation Partnership Program

State and local governments, Tribes, non-profits and others can apply to target conservation funding to certain geographies to address specific natural resource challenges. A majority of RCPP funding is provided directly to producers and landowners who implement conservation measures (for example, forest stand improvement) or place conservation easements on private lands.

Joint Chiefs' Landscape Restoration Program

The Joint Chiefs' Landscape Restoration Partnership enables NRCS and the Forest Service to collaborate with agricultural producers and forest landowners to invest in conservation and restoration at a large-enough scale to make a difference. Working in partnership, and at this scale, helps to reduce wildfire threats, protect water quality and supply, and improve wildlife habitat for at-risk species.

USDA Resources Available for Ranchers, Farmers, and Owners of Private Forestland

Environmental Quality Incentive Program

This is a voluntary conservation program providing financial and technical assistance to agricultural producers and non-industrial forest managers to address natural resource concerns and deliver environmental benefits, such as improved water and air quality, conserved ground and surface water, increased soil health, reduced soil erosion and sedimentation, improved or created wildlife habitat, and mitigation against drought and increasing weather volatility.

Conservation Stewardship Program (CSP)

Voluntary conservation program offering technical and financial assistance to help agricultural and forest producers take their conservation efforts to the next level and designed to compensate agricultural and forest producers who agree to increase their level of conservation by adopting additional conservation activities and maintaining their baseline level of conservation.

Emergency Assistance for Livestock Honey Bees, and Farm-raised Fish (ELAP)

USDA-FSA's Emergency Assistance for Livestock, Honey Bees, and Farm-raised Fish (ELAP) provides financial assistance to eligible producers of livestock, honeybees and farm-raised fish for losses due to disease, certain adverse weather events or loss conditions. In 2021, USDA updated ELAP policy to help cover the cost of transporting feed for livestock that rely on grazing. By helping transport feed to livestock and livestock to feed, and by covering water hauling costs in key areas, this program helps keep ranchers ranching while preventing additional stress on drought-stricken land that may be vulnerable to fire.

DOI Resources Available for Communities

The America the Beautiful Challenge (ATBC) is funded by the Ecosystem Restoration provision for “Grants for Voluntary Restoration.” That proposal includes the following program priorities, which are explicitly complementary to the Community Wildfire Defense Grants:

- **Strengthen Ecosystem and Community Resilience.** Conserve and restore natural systems that help ecosystems and/or communities respond to, mediate, and recover from disturbances such as floods, wildfire, drought (e.g., enhancing a wetland to improve coastal resilience, invasive species prevention or removal to reduce wildfire risk, restoring fire resilient stand structure and species composition in fire prone forests, water conservation to address drought, expansion of wetlands to protect from flooding, grassland restoration to promote natural prairie ecosystems).
- **Expand Habitat Connectivity.** Conserve and restore priority habitat and stopover areas along key migratory routes; conserve, restore or improve fish passage; conserve or restore lands and/or waters that are critical to habitat connectivity; or expand and enhance wildlife corridors that contribute to larger-scale conservation efforts (e.g., removing and right-sizing culverts, removing encroaching trees from grassland and sagebrush ecosystems, rehabilitating areas damaged by fire, treating exotic/invasive vegetation to improve habitat values, or voluntary conservation easements to strengthen habitat connectivity).
