RELATING TO HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII: Section 213.6 of the Hawaiian Homes Commission SECTION 1. 1 Act, 1920, as amended, is amended to read as follows: 2 "[+]§213.6.[+] Hawaiian home lands trust fund. 3 There is established [in-the-treasury-of-the-State] a trust fund to be 4 known as the Hawaiian home lands trust fund, into which shall be 5 deposited all appropriations by the [State] state legislature 6 specified to be deposited therein. Moneys of the Hawaiian home 1 lands trust fund shall be expended by the department, as 8 provided by law, upon approval by the commission and shall be 9 used for capital improvements and other purposes undertaken in 10 furtherance of the Act. The department shall have a fiduciary 11 responsibility toward the trust fund $[\tau]$ and shall provide annual 12 reports therefor to the legislature and to the beneficiaries of 13 the trust. 14 The commission may deposit moneys from the trust fund into 15 16 depositories other than the state treasury and may manage, invest, and reinvest moneys in the trust fund. securities and investments in which any of the moneys have been 1 invested, as well as the proceeds of the investments. Moneys 2 from the trust fund that are deposited into depositories other 3 than the state treasury shall be exempt from the requirements of 4 chapters 36 and 38. Any interest or other earnings arising out 5 of investments from the trust fund shall be credited to and 6 7 deposited into the trust fund." The provisions of the amendments made by this 8 SECTION 2. 9 Act to the Hawaiian Homes Commission Act, 1920, as amended, are declared to be severable, and if any section, sentence, clause, 10 or phrase, or the application thereof to any person or 1 circumstances is held ineffective because there is a requirement 12 of having the consent of the United States to take effect, then 13 that portion only shall take effect upon the granting of consent 14 by the United States and effectiveness of the remainder of these 15 16 amendments or the application thereof shall not be affected. Statutory material to be repealed is bracketed 17 SECTION 3. and stricken. New statutory material is underscored. 18 19 SECTION 4. This Act shall take effect upon approval.
