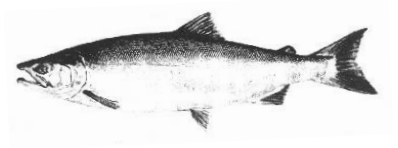

**2017 Yukon River Fall Salmon Fishery News Release # 26
District 2 Commercial Period 6
Districts Affected: Lower Yukon Area
Fall Season Emergency Order # 24**

District 2 Commercial Fishing:

Commercial fishing will be open for one period in **District 2, from 5:00 p.m. until 9:00 p.m., Wednesday, August 9.** This will be a 4-hour commercial fishing period with gillnets restricted to 6-inch or smaller mesh size. **Commercial fishermen should confirm their buyer before they fish. There will be no tenders operating for this commercial period. Fishermen will only be able to make deliveries to buying stations at St. Mary's and Mountain Village.**

The sale of Chinook salmon is prohibited. Commercial gillnet fishermen can release live Chinook salmon or use them for subsistence purposes. Chinook salmon retained from commercial gillnet gear must be recorded on a fish ticket as retained but not sold.

Verbal reports from District 2 period 5 commercial opening on August 4 indicate a preliminary harvest of 4,765 fall chum and 768 coho salmon from 84 deliveries. The preliminary total commercial harvest to date in District 2 is 39,273 fall chum and 853 coho salmon.

District 2 Subsistence Fishing Schedule:

Subsistence salmon fishing in District 2 is open during the fall season 7 days per week, 24 hours per day with gillnets restricted to a maximum mesh size of 7.5 inches, except for closures before, during and after commercial fishing periods. **For this commercial period, subsistence fishing will close at 5:00 a.m. Wednesday, August 9, and reopen at 9:00 a.m. Thursday, August 10.** Fishermen may use 4-inch or smaller mesh size gillnets to target non-salmon species during subsistence salmon closures.
