## 2019 Yukon River Fall Salmon Fishery News Release # 3 District 1 Commercial and Subsistence Fishing Schedule

Districts Affected: Lower Yukon Area

The 2019 fall chum salmon preseason projection, based on the relationship between summer chum to fall chum salmon run sizes, is for a run size of 625,000 fall chum salmon with a range of 500,000 to 750,000 fish. Run sizes within this range are expected to provide for escapement and subsistence use needs. In accordance with the *Yukon River Drainage Fall Chum Salmon Management Plan*, a threshold run size of 550,000 fish is necessary to open a fall chum salmon directed commercial fishery. Commercial fishing would be allowed on the surplus above that level. During the transitional period between the summer and fall seasons, a large number of summer chum salmon are still entering the river. A commercial period at this time would harvest a mixture of both summer and fall chum salmon. Fishermen should standby for future announcements regarding commercial fishing.

Commercial fishermen intending to fish in the Set Net Only Area of District 1 are required to register with the department prior to the opening. Registration can be completed by calling the Emmonak Fish and Game office at 949-1320.

### **District 1 Commercial Fishing:**

Commercial fishing will open with 6-inch or smaller mesh gillnets:

- Set Net Only Area: 9-hour period on Thursday, July 18 from 3:00 p.m. until 12:00 midnight.
- Remainder of District 1: 6-hour period on Thursday, July 18 from 6:00 p.m. until 12:00 midnight.

Chinook salmon may be sold during these commercial openings. All Chinook salmon sold or retained for subsistence during commercial openings must be recorded on a fish ticket.

#### Pastolik and Pastoliak Rivers:

The Pastolik and Pastoliak rivers near Apoon Pass, including 500 yards around their mouths, are closed to commercial fishing (see map below). Also, subsistence fishing with gillnets, including gillnets with 4-inch mesh or less, is closed in these waters 12 hours before, during, and 12 hours after each commercial opening.


#### **District 1 Subsistence Fishing:**

Subsistence salmon fishing in District 1, is open during the fall season 7 days per week, 24 hours per day with 7.5-inch or smaller mesh gillnets, except for 12 hours before, during, and 12 hours after each commercial fishing period. Subsistence salmon fishing, including the Pastolik and Pastoliak Rivers, will close at 3:00 a.m. Thursday, July 18, and reopen at 12:00 noon Friday, July 19.

Subsistence fishermen must remove both tips of the tail fin of Chinook salmon before concealing from plain view or leaving the fishing site.
