## Report of DOI Conference Activities and Spending – Fiscal Year 2013

The Department has implemented internal controls over conference spending and activities in conformance with the President's Campaign to Cut Waste, Executive Order 13589 -- *Promoting Efficient Spending*, and Office of Management and Budget (OMB) memorandum M-12-12 *Promoting Efficient Spending to Support Agency Operations*, and the *Consolidated and Further Continuing Appropriations Act*, 2013. These efforts have resulted in effective controls over conference activities and spending.

Departmental policies provide a framework of internal controls designed to mitigate risks associated with conference planning, hosting and spending, and ensure compliance with Federal travel regulations. The current policy incorporates new guidance for submitting reports on large conferences and summary reports on conference spending over \$20,000 to the DOI Office of Inspector General consistent with statutory guidance contained in the *Consolidated and Further Continuing Appropriations Act*, 2013.

For Fiscal Year 2013, DOI complied with the Administration's limitation on agency-sponsored conferences with net expenses in excess of \$500,000. In compliance with OMB Memorandum 12-12 *Promoting Efficient Spending to Support Agency Operations*, and based on exceptional circumstances, the Secretary granted one waiver in Fiscal Year 2013.

## Reporting of Conferences held during FY 2013 that exceeded \$100,000 in net costs.

**Explanation:** Annual meeting with all the tribes and tribal organizations that have either P.L.93 -638 contract or P.L. 103-413 compact agreements to provide services on behalf of the Bureau. The conference participants are informed about Federal programs including Contracts & Grants, Natural Resources, Probate & Estate Services, Subsistence, Transportation, Real Estate Services, Human Services, Credit & Finance, Land Titles & Records Office, and Tribal Government.

Conference Title: School Improvement Grant Technical Assistance and Workshop

**Explanation:** The School Improvement Technical Assistance and Workshop focused on building educational capacity to improve student learning with guidance and technical assistance

as required by P.L. 107-110, No Child left Behind Act of 2001, section 1119.

**Date:** January 15, 2012 to January 17, 2013

**Explanation:** This conference provided BIA and DOI staff with a comprehensive technical understanding of the BIA leasing and permitting processes for utility-scale solar energy development on Indian lands. This includes the new BIA wind and solar leasing regulations, leasing terms, financing and environmental review of tribal solar projects. The workshop facilitated interactive discussions while sharing lessons learned from the field. The Office of Indian Energy and Economic Development, Argonne National Laboratory and the National Renewable Energy Laboratory worked together to develop a three day curriculum for this utility-scale solar workshop.

**Explanation**: The Principal Leadership Academy (PLA) provided the BIE operated school Principals within the ADD West and ADD East regions the opportunity to become certified Rapid Improvement Leaders. BIE has developed a certification process in collaboration with the Academic Development Institute and Temple University Institute for Schools and Society.

**Conference Title:** Characterizing Tribal Cultural Landscapes Workshops

**Explanation:** Meet with invited Tribal representatives and agency partners to initiate the development of a proactive best-practices tool to work with Native American communities in order to identify areas of tribal significance that need to be considered in the planning process for offshore renewable energy projects. The workshops are critical to the overall completion of the Characterizing Tribal Cultural Landscapes inter-agency agreement, as well as securing support from non-partner tribes. Workshops are part of the BOEM-funded interagency agreement with NOAA's Marine Protected Areas Program and Maritime Heritage Program.

**Explanation**: The workshop brought together European scientific and regulatory experts to discuss scientific information collection in support of siting of offshore wind facilities. The workshop provided the opportunity for Federal and State agencies with leasing and permitting responsibilities to hear directly from European experts with direct experience in offshore wind development. The technical focus of the workshop was on birds, seafloor habitats, and archaeology.

Conference Title: Quieting Technologies for Reducing Noise during Seismic Surveying and

Pile Driving

**Explanation**: The BOEM organized workshop brought together government, industry, nongovernmental, and academic experts from the United States and several countries to examine quieting technologies to reduce the impacts of noise generated during offshore exploratory seismic surveys, pile driving and the vessels associated with these activities. This provided BOEM and other regulatory agencies with information needed to determine the usefulness and appropriateness of these alternative and quieting technologies for mitigation and monitoring to lower the overall sound introduced into the water.

This all-waterfowl symposium is the first to be held since 1987. It allows scientists and managers from all over North America to share and knowledge and information about waterfowl and their habitats.
